Dear County Executive Picente:

In April 2005, Oneida County joined the Central New York Regional Transportation Authority (CNYRTA), which ultimately assumed all operations of the Utica Transit Authority (UTA) and the Rome VIP Transportation.

As required by state law, an annual local match to the State Transportation Operating Assistance in the amount of \$515,153.80 is paid to CNYRTA by the county. The county entered into five year agreements with the cities of Rome and Utica, and the towns of New Hartford, Whitestown and Kirkland to reimburse the county for the local match based on the historic local share each had previously paid for many years. These agreements were negotiated under the previous administration under the premise of holding the municipalities harmless from any additional cost while maintaining the existing transit service.

Centro of Oneida has done an outstanding job by upgrading the fleet of buses and increasing the ridership at no additional cost to the municipalities. All have benefited greatly by the Centro takeover of the two transit systems which were in financial trouble and in danger of going out of business.

On December 31, 2009, the current five year agreements between the municipalities and the county for local share reimbursements to the county are set to expire.

I propose that the municipalities continue to pay their current local contribution to the county for another five years. These are the amounts each municipality would be paying now had they continued under the previous transit operations. The hold harmless approach agreed to five years ago is still valid and its continuation for another five years will result in continued public transit service for all at no significant additional cost for a total of ten years.

Attached is the new five year agreement for the City of Rome in the annual amount of \$220,000. for the period January 1, 2010 through December 31, 2014, for consideration by the Board of Legislators

#### INTERMUNICIPAL AGREEMENT

This agreement made this day of , 2009, by and between the County of Oneida, a municipal corporation with offices at 800 Park Avenue, Utica, New York, 13501, hereinafter referred to as "County" and the City of Rome, a municipal corporation with offices at City Hall, Rome, New York, 13440, hereinafter referred to as "City".

#### WITNESSETH

WHEREAS, it is the intention of the County and the City to continue to provide affordable bus transportation to its citizens by means of the County joining the Central New York Regional Transportation Authority, hereinafter "CNYRTA", and

WHEREAS, there are certain monies required to be paid to CNYRTA as a local match to State and Federal Operating Funds for its transit operations, and

WHEREAS, the City wishes to enter into an agreement with the County as to the payment of such local share so that bus transportation in the City remains in place, and

WHEREAS, the County is the municipal entity permitted to join the CNYRTA system pursuant to the "Central New York Regional Transportation Act",

NOW THEREFORE, in consideration of the mutual promises made herein, the County and the City agree as follows:

- 1. The City agrees to pay over to the County the sum of Two Hundred Twenty Thousand and 00/100 Dollars (\$220,000.00) each year for the years 2010, 2011, 2012, 2013 and 2014. This sum shall represent and be in payment of the equivalent of the City's percentage of the local funding match to the State and Federal Operating Funding allowed for the operation of CNYRTA and required to be paid to CNYRTA by the County.
- 2. After receipt of such funds by the County, the County agrees to deposit such funds and pay over to CNYRTA, on behalf of the City of Rome, the sum of Two Hundred and Twenty Thousand and 00/100 Dollars (\$220,000.00) each year for the years 2010, 2011, 2012, 2013 and 2014.
- 3. The monies paid over by the City to the County and subsequently paid over by the County to CNYRTA, pursuant to this agreement, shall be for the continued provision of bus transportation services to the citizens of the City of Rome.
- 4. The term of this agreement shall be from January 1, 2010 until December 31, 2014, unless otherwise agreed to by the parties in writing.

5. The City agrees to make such payment to the County no later than February 1<sup>st</sup> of each year of this agreement.

**WAYS & MEANS** 

I am requesting the Board of Legislators consideration and approval of an increase in the expenses necessary to collect the mortgage tax receipts. This is based on Section 262 of the Tax Law. As provided in Tax Law Section 262, the requested reimbursement must be approved by the Tax Commission and accompanied by a resolution approved and passed by the Board before April 1, 2010. This process was developed seven years ago to make yearly increases based on the rate of inflation rather than make larger increases at longer intervals. The expenses the Clerk's Office incurs went up this year and the current rate does not adequately reimburse the Clerk's Office for the cost of collecting this tax.

The Clerk's Office is requesting that we be allowed to charge the State of New York the actual cost of annually collecting the mortgage tax proceeds. We are requesting that the current charge be raised based on the increased yearly cost incurred by the County to \$402,748.00. As stated above, this increase requires Board action and must be to the STATE OF NEW YORK BY APRIL 1ST, 2010 in order to take effect.

On December 30, 2008, the Oneida County Board of Legislators approved a contract with JMZ Architects and Planners to prepare plans & specifications and provide construction administration services or the new Robert R. Jorgensen Athletics/Events Center. Approved fees and approved methods of calculating fees were based on formulas developed and approved by the NYS University Construction Fund.

The initial construction budget was an estimated \$10,000,000.00 which resulted in an estimated fee of \$737,250.00. As part of the 2010 budget, the Oneida County Board of Legislators approved additional funding for the Athletic Events Center as well as funding for renovation of the pool in the existing gymnasium facility. These appropriations increased the construction budget too approximately \$14,000,000.00.

An increased construction budget demands additional work from the Architect so JMZ was directed to provide the attached revised fee schedule. Again, this fee was calculated by using formulas developed by the NYS University Construction Fund and approved by the Oneida County Board of Legislators as noted above. On December 30, 2009, the Oneida County Board of Acquisition and Contract approved the attached fee schedule with a revised fee estimate of \$1,124,120.00.

Therefore, please consider the enclosed amendment that would increase the maximum amount payable from \$737,205.00 to \$1,124,120.00. This represents a \$386,870.00 fee increase.
