Thank you for your assistance in this matter.

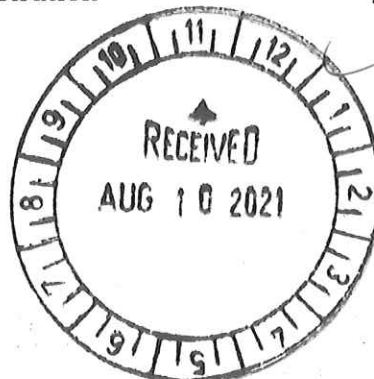
