LOCAL LAW INTRO. "B" OF 2021 LOCAL LAW NO. ____ OF 2021

A LOCAL LAW ADOPTING A PILOT YOUTH DEER HUNTING PROGRAM

BE IT ENACTED BY THE BOARD OF COUNTY LEGISLATORS OF THE COUNTY OF ONEIDA, STATE OF NEW YORK, AS FOLLOWS:

SECTION 1. PURPOSE AND INTENT.

The intent of this Local Law is to authorize Oneida County to permit 12 and 13 year old individuals to participate in the new and safe hunting opportunities in accordance with Environmental Conservation Law § 11-0935. The enacted 2021-2022 New York State Budget includes a pilot program allowing the opportunity for young hunters, ages 12 and 13, to hunt deer with firearms and crossbows through 2023 if a county authorizes such action within their municipality. Oneida County is passing this Local Law as hunting is a valued tradition for many families, and this new opportunity allows experienced, adult hunters to introduce the value of hunting to the next generation. Furthermore, teaching young people safe, responsible, and ethical hunting practices will ensure a rewarding experience for the youth, while providing quality food to families and contributing to important deer management population control practices.

SECTION 2. AUTHORITY.

This Local Law is adopted under the authority granted by:

- A. Article IX of the New York State Constitution, § 2[c];
- B. New York Municipal Home Rule Law, § 10; and
- C. New York Environmental Conservation Law § 11-0935.

SECTION 3. DEFINITIONS.

A. "Eligible Area" means any county within the State of New York that has enacted a local law authorizing participation in

a youth hunting pilot program, and has notified the New York State Department of Environmental Conservation of such participation.

- B. "Hunting License Holder" means a person who has successfully completed a hunter education/safety course, and currently holds a valid hunting license issued by the New York State Department of Environmental Conservation.
- C. "Minor" means a youth twelve or thirteen years of age who currently holds a valid hunting license issued by the New York State Department of Environmental Conservation to hunt deer with a crossbow, rifle, shotgun, or muzzle-loading firearm within an eligible area.
- D. "Parent, Legal Guardian or Designated Person" means the parent or legal guardian of a Minor, or a person designated in writing by such parent or legal guardian on a form prescribed by the New York State Department of Environmental Conservation who (1) is twenty-one years of age or older, (2) is a Hunting License Holder and (3) has had at least three years of prior experience in hunting deer.
- E. "Physical control" means that the physical proximity of a Minor to a Parent, Legal Guardian or Designated Person and is such that the Parent, Legal Guardian or Designated Person is (a) reasonably able to issue verbal directions and instructions, (b) maintain constant visual contact, and (c) otherwise able to provide guidance and supervision to the Minor.

SECTION 4. PILOT PROGRAM AUTHORIZATION.

Pursuant to Environmental Conservation Law, ECL § 11-0935, Oneida County elects to participate in the temporary program to allow for Minors to hunt deer with a firearm, to include rifles, shotguns, and muzzle-loading firearms or crossbows through December 31, 2023.

SECTION 5. ELIGIBILITY AND REQUIREMENTS.

- A. A Minor may hunt deer with a crossbow, rifle, shotgun, or muzzle-loading firearm within the County of Oneida when accompanied by, and is under the Physical Control of, a Parent, Legal Guardian or Designated Person as those terms are defined by Section 3 of this Local Law.
- B. A Minor participating in the Pilot Youth Deer Hunting Program in Oncida County must be a Hunting License Holder and must be in possession of valid tags, as appropriate, while afield at all times. The accompanying Parent, Legal Guardian or Designated Person must also be a Hunting License Holder at all times when supervising a Minor participating in the Pilot Youth Deer Hunting Program.
- C. A Minor and the accompanying Parent, Legal Guardian or Designated Person must display either a minimum total of two hundred and fifty (250) square inches of solid fluorescent orange or pink or patterned fluorescent orange or pink consisting of no less than fifty (50) percent fluorescent orange or pink material worn above the waist and visible from all directions, or a hat or cap with no less than fifty (50) percent of the exterior consisting of solid fluorescent orange or pink material and visible from all directions.
- D. A Minor participating in the Pilot Youth Deer Hunting Program must remain at ground level at all times when hunting deer with a crossbow, rifle, shotgun, or muzzle-loading firearm.
- E. A Minor participating in the Pilot Youth Deer Hunting Program must remain within the Physical Proximity of a Parent, Legal Guardian or Designated Person at all times.
- F. A Minor participating in the Pilot Youth Deer Hunting Program must abide by all other federal, state and local laws, rules and regulations applicable to hunting including, but not limited to, manner of take, bag limits, hunting hours, geographical or general implement restrictions, hunting seasons, tagging, transporting and reporting requirements.

SECTION 6. FILING.

In accordance with ECL § 11-0935(2), a copy of this Local Law shall be filed with the New York State Department of Environmental Conservation. And in accordance with Municipal Home Rule § 27, a copy shall be filed with the New York State Department of State.

SECTION 7. SEVERABILITY.

If any clause, sentence, paragraph, subdivision, section, or part of this Local Law or the application thereof to any person, individual, corporation, firm, partnership, entity, or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this Local Law, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

SECTION 8. EFFECTIVE DATE.

This Local Law shall be effective upon its filing with the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.
