COUNTY OF ONEIDA RENEWAL OF LOCAL EMERGENCY ORDERS 2 AND 3 OF 2023

WHEREAS, by proclamation dated May 11, 2023 and continuously renewed, the County Executive of the County of Oneida has declared a local state of emergency within the County in connection with the expiration of an order of the United States Centers for Disease Control and Prevention that prohibited the introduction into congregate settings of noncitizens arriving from or through Mexico and Canada, thereby dramatically increasing the possibility, already significant, that persons will enter the United States; and

WHEREAS, in the last year, the State of Texas has transported tens of thousands of persons from Texas to the City of New York, and even more have moved to the City on their own initiative, all straining the City's homeless and emergency services, and as a result, in May 2023 the Mayor of the City of New York announced plans to bus persons arriving in the City to counties outside of the City of New York without assessing the capabilities of those counties to house, feed, and serve such vulnerable populations; and

WHEREAS, pursuant to Local Emergency Order 2 of 2023 ("Local Emergency Order 2"), dated June 2, 2023 and continuously renewed, the County Executive prohibited businesses, hotels, motels, shelters, multiple dwellings, and campgrounds from entering into contracts with municipalities, including the City of New York, to transport or house Persons or Migrants, as defined therein, to or within the County unless the County Executive determines that such agreements or contracts would not jeopardize the health, safety, or welfare of the County and its residents; and

WHEREAS, in September 2023 the Mayor of the City of New York—in an unlawful effort to evade and subvert Local Emergency Order 2 through extrajudicial means—announced plans to expand the New York City Fighting Homelessness and Eviction Prevention Supplement ("City FHEPS") program by providing up to five years of rental vouchers to New York City residents who relocate from New York City to counties in upstate New York and Long Island; and

WHEREAS, pursuant to Local Emergency Order 3 of 2023 ("Local Emergency Order 3"), dated September 28, 2023, the County Executive prohibited the acceptance within the County of New York City FHEPS vouchers, absent written authorization by the County of Oneida; and

WHEREAS, the circumstances necessitating Local Emergency Order 2 and Local Emergency 3 have not abated, and therefore the emergency orders must be extended in order to secure the health and safety of Oneida County and its residents;

NOW THEREFORE, by the power vested in me by New York State Executive Law Section 24 and Oneida County Administrative Code Section 302(k), it is hereby ORDERED that the Local Emergency Order 2, annexed as Exhibit A, is extended and shall remain in effect for an additional period of five (5) days from the date hereof, and Local Emergency Order 3, annexed as Exhibit B, is extended and shall remain in effect for an additional period of five (5) days from the date hereof.

This Renewal Order shall be executed in quadruplicate and filed within seventy-two hours or as soon thereafter as practicable in the office of the Clerk of Board of Legislators, the office of the County Clerk, the New York Secretary of State, and the New York State Office of Emergency Management within the Division of Homeland Security and Emergency Services.

COUNTY OF ONEIDA LOCAL EMERGENCY ORDER 2 OF 2023

WHEREAS, by proclamation dated May 11, 2023, the County Executive of the County of Oneida declared a local state of emergency within the County in anticipation of the expiration of an order of the United States Centers for Disease Control and Prevention that prohibited the introduction into congregate settings of noncitizens arriving from or through Mexico and Canada (the "COVID-19 Migration Order"), thereby dramatically increasing the risk, already significant, that persons, including migrants and asylum seekers, will unlawfully enter the United States; and

WHEREAS, there is a national immigration crisis at the border between the United States and Mexico, creating a dramatic increase in the number of persons seeking asylum or who have illegally entered and remained in the United States, and the federal government has failed to anticipate or react to the exigent and emergent circumstances, resulting in thousands of persons crossing the United States border; and

WHEREAS, in the last year, the State of Texas has transported tens of thousands of persons from Texas to the City of New York, a "sanctuary city," straining the City's homeless, social, health, and emergency services and resulting in reported costs to the City in excess of \$4 billion; and

WHEREAS, on May 5, 2023, as a result of the strain placed on the City of New York, the Mayor of the City of New York announced plans to bus persons, including migrants and asylum seekers (each a "Person or Migrant," and collectively, the "Persons or Migrants") arriving in the City to counties outside of the City of New York, without assessing the capabilities of counties outside of the City of New York to house and feed vulnerable Person or Migrant populations and lacking all authority or jurisdiction to require the same; and

WHEREAS, the County of Oneida strives to be a welcoming community and recognizes the contributions of refugees, immigrants, and lawful migrants to the County's development and emergence as the cultural and economic center of the State; however, unrestricted, unlawful migration poses a grave risk to the social, health, and emergency services resources of the County, particularly during this period of economic growth when the County's inventory of housing and emergency housing is at historic lows; and

WHEREAS, the County of Oneida is responsible for securing the health and safety of its residents, and should the City of New York abruptly transport large numbers of Persons or Migrants to the County, the mass arrival of these Persons or Migrants will create a social, health, and emergency services crisis, causing an increase in homelessness, threatening the health and public safety of County residents and any relocated Persons or Migrants;

NOW THEREFORE, by the power vested in me by New York State Executive Law Section 24 and Oneida County Administrative Code Section 302(k), it here hereby ORDERED:

Section 1. Prohibition of contracts with municipalities to transport or house Persons or Migrants that jeopardize the health, safety, or welfare of the County.

- A. No person, business or entity doing business within the County of Oneida shall agree or contract with any municipality to transport to or within the County of Oneida any Person or Migrant without the prior written permission of the County Executive or his designee, such permission to be given only after determining that such agreement or contract would not jeopardize the health, safety, or welfare of the County and its residents.
- B. No hotel, motel, shelter, campground, or owner of a multiple dwelling in the County of Oneida shall agree or contract with any municipality to sell, lease, rent, or otherwise provide hotel rooms, housing, campgrounds, motel rooms, or short-term rentals to any Person or Migrant without the prior written permission of the County Executive or his designee, such permission to be given only after determining that such agreement or contract would not jeopardize the health, safety, or welfare of the County and its residents.
- C. As conditions to granting the permissions described in paragraphs A and B of this Section 1, the County Executive or his designee shall require each agreement or contract with a municipal counterparty to:
 - i. Provide a date certain for the return or relocation of the Person or Migrant to the jurisdiction of the municipal counterparty;
 - ii. Require the municipal counterparty to provide all funding to sustain the needs of the Person or Migrant during his or her stay in the County;
 - iii. Assume all costs of the County and any political subdivision within the County arising from the agreement or contract to transport or house the Person or Migrant, including costs for the care, welfare, law enforcement interactions, or other interactions; and
 - iv. Provide to the County a bond securing the municipal counterparty's obligations as set forth in this Section 1(C) in an amount not less than Two Thousand Dollars and Zero Cents (\$2,000.00) per each Person or Migrant.

Section 2. Penalties and Remedies.

- A. Pursuant to New York State Executive Law Section 24(5), any person who, or entity which, knowingly violates the provisions of this Local Emergency Order shall be guilty of a class B misdemeanor. The Oneida County Sheriff is authorized to issue appearance tickets for any such knowing violation of this Local Emergency Order.
- B. In addition to the foregoing penalty, any person who, or entity which, knowingly violates any provision of this Local Emergency Order or any term or condition of the permissions authorized hereby shall be liable for a civil penalty of Two

Thousand Dollars and Zero Cents (\$2,000.00) per day, and per each Person or Migrant transported to or within the County or housed within the County in violation of this Local Emergency Order. The civil penalties provided by this paragraph shall be recoverable in an action instituted in the name of the County and initiated by the County.

- C. Regardless of any other penalty, remedy or relief sought by the County for any violation of this Local Emergency Order, the County Attorney may commence actions or proceedings in the name of the County, in a court of competent jurisdiction, to abate any violations of this Local Emergency Order.
- D. The penalties or remedies of this Local Emergency Order are not exclusive of any other remedy or penalty, but are in addition to all such other remedies and penalties and may be pursued at any time whether prior to, simultaneously with, or following any other remedy or penalty.

Section 3. Comprehensive Emergency Management Plan. Pursuant to the Oneida County Comprehensive Emergency Management Plan, the County Executive and the Oneida County Director of Emergency Services shall activate and initiate all processes necessary to effectuate the provisions of this Local Emergency Order.

Section 4. Severability. If any clause, sentence, paragraph or part of this Local Emergency Order shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part of this Local Emergency Order so adjudged to be invalid.

Section 5. Effective Date and Expiration. This Local Emergency Order shall take effect immediately and shall remain in effect for a period of five (5) days. This Local Emergency Order may be renewed for additional periods of five (5) days each.

Section 6. Supersession of Previous Local Emergency Order. This Local Emergency Order replaces and supersedes Local Emergency Order 1 of 2023 (as renewed).

This Local Emergency Order shall be executed in quadruplicate and filed within seventy-two hours or as soon thereafter as practicable in the office of the Clerk of Board of Legislators, the office of the County Clerk, the New York Secretary of State, and the New York State Office of Emergency Management withing the Division of Homeland Security and Emergency Services.

COUNTY OF ONEIDA LOCAL EMERGENCY ORDER 3 OF 2023

WHEREAS, by proclamation dated May 11, 2023, renewed on June 10, 2023, July 10, 2023, August 10, 2023, and September 10, 2023, the County Executive of the County of Oneida has declared a local state of emergency within the County in anticipation of the expiration of an order of the United States Centers for Disease Control and Prevention that prohibited the introduction into congregate settings of noncitizens arriving from or through Mexico and Canada, thereby dramatically increasing the possibility, already significant, that persons, including migrants and asylum seekers, will enter the United States; and

WHEREAS, there is a national immigration crisis at the border between the United States and Mexico, creating a dramatic increase in the number of persons seeking asylum or who have illegally entered and remained in the United States, and the federal government has failed to anticipate or react to the exigent and emergent circumstances, resulting in thousands of persons crossing the United States border; and

WHEREAS, in 1984, the City of New York agreed to a consent judgment guaranteeing shelter in the City of New York to all persons who apply and qualify for shelter, and in 1989 the City of New York issued an executive order establishing the City of New York as a "sanctuary city" for federal immigration purposes, which such status the New York City Council reaffirmed by resolution adopted in 2016; and

WHEREAS, in the last year, the State of Texas has transported tens of thousands of persons from Texas to the City of New York on the basis of its status as a "sanctuary city"; and

WHEREAS, also in the last year, tens of thousands of persons who have entered the country have, of their own volition, migrated to settle in New York City; and

WHEREAS, in May 2023, the Mayor of the City of New York, on the basis of overwhelmed City agencies and stress on City resources, announced plans to bus persons from the City of New York to hotels and motels in counties outside of the City of New York, in violation of the United States and New York State constitutions and statutes and without regard to those counties' capabilities to house, feed, and serve such populations amidst those counties' own homeless and mental health services crises; and

WHEREAS, in response to the Mayor of the City of New York's unlawful busing program, the Oneida County Executive issued Local Emergency Order 2 of 2023—which remains in effect—barring local hotels, motels and others from contracting with the City of New York to transport or house New York City migrants, asylum seekers, or other persons without first establishing that such contract will not jeopardize the health, safety, or welfare of the County or its residents ("Local Emergency Order 2"); and

WHEREAS, the County has a disproportionately large homeless population and struggles to house and shelter its vulnerable residents, particularly during the winter months when all shelter housing, all available motel housing, and all collaborative rental housing is full; and indeed, on the coldest days of the year the County has had no choice but to open County buildings to the homeless overnight; and

WHEREAS, the County of Oneida, like New York City and other counties throughout New York State, is contending with its own housing shortage, homelessness crisis and overtaxed social services and non-profit service providers; and

WHEREAS, the City of New York challenged Local Emergency Order 2 by commencing a lawsuit in the New York State Supreme Court, New York County, but the Court determined that the City failed to select a proper venue for the lawsuit and ordered that the action be severed as to Oneida County and transferred to the Supreme Court, Oneida County; after which decision, the City of New York voluntarily discontinued the lawsuit; and

WHEREAS, by press release dated September 26, 2023, the Mayor of the City of New York—in an effort to evade and subvert Local Emergency Order 2 through extrajudicial means—announced plans to expand the New York City Fighting Homelessness and Eviction Prevention Supplement ("City FHEPS") program by providing five years (or more) of rental vouchers to New York City residents who agree to relocate from New York City to counties in upstate New York and Long Island (the "City of New York Homeless Relocation Program"); and

WHEREAS, by videoconference on September 26, 2023, the City of New York confirmed that although it will be providing five years of rental payments to homeless who agree to relocate to upstate New York and Long Island, the City will divest itself of the obligation to pay for the attendant social services, educational services, and all other support for the homeless persons it relocates; and

WHEREAS, the City of New York Homeless Relocation Program violates the City's 1984 consent judgment and is unlawful under the United States and New York State statutes and constitutions, including Article IX of the New York Constitution, which secures to Oneida County the right of local self-government and which further requires local governments to secure intergovernmental cooperation by formal agreement as authorized by the New York State Legislature, not by unilateral fiat; and

WHEREAS, the County of Oneida strives to be a welcoming community; however, the unlawful City of New York Homeless Relocation Program poses a grave risk to the social, health, and emergency services resources of the County, particularly because the County's number of homeless is at all-time highs, causing the County's inventory of affordable housing and emergency housing to reach historic lows; and

WHEREAS, the County of Oneida is responsible for securing the health and safety of its residents, and should the City of New York transport large numbers of persons to the County, the mass arrival of these persons will create a social, health, and emergency services crisis, causing an increase in

homelessness, threatening the health and public safety of County residents and any relocated persons;

NOW THEREFORE, by the power vested in me by New York State Executive Law Section 24 and Oneida County Administrative Code Section 302(k), it here hereby ORDERED:

Section 1. Prohibition of Acceptance Within the County of New York City FHEPS Vouchers, Absent Written Authorization By The County of Oneida.

- A. No person, business, or other entity within the County of Oneida shall accept or agree to accept, by lease agreement or otherwise, a New York City FHEPS rental voucher or other voucher without first applying for and obtaining the prior written authorization of the County Executive or his designee, such authorization to be given only after determining that such agreement would not jeopardize the health, safety, or welfare of the County and its residents.
- B. Such application for authorization shall be in the form approved by the County Executive or his designee and shall, at a minimum, identify the address of the property, the term of the lease or other agreement, the monthly rent amount, the amount of the proposed New York City FHEPS voucher, and the legal names, birthdates, current addresses (if any) of all persons to be housed at the property; and any and all records pertaining to services requested by such persons or administered to such persons by the City of New York.
- C. As conditions to granting the authorization described in paragraph A of this Section 1, the County Executive or his designee shall require each person, business or entity seeking to accept New York City FHEPs rental vouchers or other vouchers to:
 - i. First have provided the County of Oneida with notice and opportunity to elect to furnish an equivalent rental voucher to a client of the Oneida County Department of Family & Community Services ("DFCS") who seeks housing or shelter. Such person, business, or entity shall satisfy this subparagraph by furnishing to the County of Oneida a written declination of DFCS to so match the New York City FHEPS rental voucher, in such form as promulgated by DFCS in its reasonable discretion; and
 - ii. Require the City of New York to be a non-tenant party to the lease or other agreement, and require the City of New York to agree to, in addition to paying rental assistance to the voucher recipient, pay to the County of Oneida all social services, educational, and other governmental costs of the persons relocated from the City of New York to the County of Oneida, in such amount as reasonably determined by the County of Oneida upon review of the application materials identified in Section 1(B) hereof. The County of Oneida shall allocate such payments to all applicable taxing jurisdictions and districts on a pro rata basis.

D. The County Executive or his designee, in granting the authorization described herein, may impose such additional conditions as he, in his reasonable discretion, deems necessary to protect the health, safety, or welfare of the County and its residents.

Section 2. Penalties and Remedies.

- A. Pursuant to New York State Executive Law Section 24(5), any person who, or entity which, knowingly violates the provisions of this Local Emergency Order shall be guilty of a class B misdemeanor. The Oneida County Sheriff is authorized to issue appearance tickets for any such knowing violation of this Local Emergency Order.
- B. In addition to the foregoing penalty, any person who, or entity which, knowingly violates any provision of this Local Emergency Order or any term or condition of the authorization provided hereby shall be liable for a civil penalty of Two Thousand Dollars and Zero Cents (\$2,000.00) per day. The civil penalties provided by this paragraph shall be recoverable in an action instituted in the name of the County and initiated by the County.
- C. Regardless of any other penalty, remedy or relief sought by the County for any violation of this Local Emergency Order, the County Attorney may commence actions or proceedings in the name of the County, in a court of competent jurisdiction, to abate any violations of this Local Emergency Order.
- D. The penalties or remedies of this Local Emergency Order are not exclusive of any other remedy or penalty, but are in addition to all such other remedies and penalties and may be pursued at any time whether prior to, simultaneously with, or following any other remedy or penalty.
- Section 3. Comprehensive Emergency Management Plan. Pursuant to the Oneida County Comprehensive Emergency Management Plan, the County Executive and the Oneida County Director of Emergency Services shall activate and initiate all processes necessary to effectuate the provisions of this Local Emergency Order.

Section 4. Severability. If any clause, sentence, paragraph or part of this Local Emergency Order shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part of this Local Emergency Order so adjudged to be invalid.

Section 5. Effective Date and Expiration. This Local Emergency Order shall take effect immediately and shall remain in effect for a period of five (5) days. This Local Emergency Order may be renewed for additional periods of five (5) days each.

This Local Emergency Order shall be executed in quadruplicate and filed within seventy-two hours or as soon thereafter as practicable in the office of the Clerk of Board of Legislators, the office of the County Clerk, the New York Secretary of State, and the New York State Office of Emergency Management withing the Division of Homeland Security and Emergency Services.
