## **FOOD SERVICE PROGRAMS SPECIALIST**

<u>DISTINGUISHING FEATURES OF THE CLASS:</u> The work involves responsibility for the organization and management of data and program-specific information using various computer systems, databases, and/or spreadsheet software on a computer. Incumbents operate within various computer software systems to update and maintain program and student data, including, but not limited to, program inventory, menu planning, and nutritional analysis, free and reduced application processing and point of sale information. Incumbent may provide technical and professional support to food service personnel of participating districts involved in the program. This work requires accuracy and understanding of the local, state, and federal guidelines of school lunch programs. The work is performed under the direct supervision with latitude allowed for scheduling and executing day-to-day duties and responsibilities. The incumbent does related work as required.

## TYPICAL WORK ACTIVITIES: (Illustrative Only)

Works with food service personnel at school districts participating in the program to implement train and support various program related systems;

Communicates with customers to understand issues, needs, or concerns;

Coordinates interaction of appropriate internal resource to work through issue, need, or concern, and follows up on open issues;

Enters data in computerized system;

Works with parents and families to process and update free and reduced lunch applications;

Develops, maintains, and updates computerized records containing information requires for specialist programs;

Searches and retrieves data from computerized records by use of quires or other means appropriate to the software;

Modifies the computerized records as program information needs change or advises vendor as to needed changes.
