- WHEREAS, The Governmental Policy and Liaison Committee (GP&L) provides a regional perspective to the development process in Herkimer and Oneida Counties, and
- WHEREAS, The Safe, Accountable, Flexible, Efficient, Transportation Equity Act: A Legacy for Users (SAFETEA-LU) and previous Federal guidelines encourage representation on the Committee by elected officials as well as transportation agencies including highway and transit, and
- WHEREAS, The Central New York Regional Transportation Authority is providing services previously provided by the Utica Transit Authority and Rome VIP transit. The Governmental Policy and Liaison Committee, at the October 27, 2005 meeting, recommended that the Chairman of the Central New York Regional Transportation Authority be added as a voting member, and
- WHEREAS, The Governmental Policy and Liaison Committee, at its March 16, 2006 meeting recommended that the Chairman of the Economic Development and Tourism Committee, Utica Common Council President, Rome Common Council President, Mohawk Valley Community Action Chairman, Utica Community Action Chairman, Utica Transit Authority Chairman, and the NYS Secretary of State be deleted as voting members of the GP&L Committee, and
- WHEREAS, The GP&L Committee also recommended that the Secretary of State and Executive Director of the Homeownership Center be added as non-voting members, now, therefore, be it hereby
- RESOLVED, That Oneida County Board of Legislators Resolution #249, adopted October 11, 1972 and amended by Resolution #15 on January 24, 1979, and amended by Resolution #362 on September 16, 1992 is hereby amended to reflect the recommended change in the voting and non-voting membership of the Governmental Policy and Liaison Committee, and it is further
- RESOLVED, That the Clerk of this Board is hereby directed to forwarded certified copies of this Resolution to the Herkimer-Oneida Counties Comprehensive Planning Program.
