#### • Director's Report

- Dana Crisino gave the following report on behalf of the Herkimer Oneida Counties Transportation Council:
  - Transportation Program Manager Dana introduces Julie Richmond as the candidate who was selected to become the Transportation Program

- Manager. Julie will be transitioned into running the day-to-day operations of the MPO by the end of September.
- Transportation Atlas The document is an extension of the current Long Range Transportation Plan and will be physically disseminated to members of the committee at the next meeting. The goal of the Transportation Atlas will be to visually show relevant information and data related to the transportation network in the Herkimer and Oneida County region. The document will be graphically rich with easily decipherable elements for use by policymakers and the public.
- Safe Streets 4 All Grant A decision was made to pursue the grant program that will develop a safety action plan for the transportation system that aims for a vision zero concept of zero serious injuries and zero deaths. The application will be a partnership between the MPO, Herkimer County, and Oneida County. The proposal will seek \$500,000 for technical assistance for a safety analysis of the local roadway network. September 15th is the deadline for proposals to be submitted. The timeline for announcements for awards has not yet been outlined. Dana will let the committee know as to what transpires regarding this topic.

#### • NYSDOT Region 2 Report

- o Deb Windecker gave a report on the activities that NYSDOT Region 2 has performed in the last quarter.
  - NYSDOT Region 2 will receive \$18 million from the federal Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant program. NYSDOT applied to the program in April 2022 and received notification on 8 August of funding award. The project is on the TIP as PIN 204707.
  - The 2022 RAISE program funded 166 projects across the country for \$2.2 billion. New York will receive a total of \$59 million spread across 5 projects ranging from \$1.1 million to \$25 million. The recipients were: the Shinnecock Nation on Long Island, the Seneca Nation in Western New York, the City of Buffalo (\$25 million), and the City of New York.
  - NYSDOT submitted a plan for the National Electric Vehicle Infrastructure (NEVI) Program to FHWA on 31 July prior to public input. The plans will be reviewed and approved by 30 September. The program will have \$175 million available over five years and will be used to invest in 150 kW electric vehicle chargers along designated electric vehicle corridors. The stations will be within one mile of the corridor and be no more than 50 miles apart. Public and private investments will occur and the MPO participates in the NEVI Formula Funding Funds for construction and maintenance.
  - Bridge New York will be funded with \$1 billion over five years, which is an increase of \$100 million annually from \$100 million to \$200 million. NYSDOT is exploring options to award additional funding. Feedback was received from town and county associations for modifications. A decision will be reached soon on the direction of the program and how to get the new funds utilized.
  - The Bipartisan Infrastructure Law (BIL)
    - The funding available to recipients from the BIL ranges from: apportioned programs (formula), bridge program (formula), National Electric Vehicle Formula Program, Safe Streets and Roads for All, PROTECT grants

(discretionary), Charging and Fueling Infrastructure, Congestion Relief, Bridge Investment (discretionary), Reconnecting Communities Pilot, Rural Surface Transportation Grants, INFRA, National Infrastructure Project Assistance, and Local and Regional Project Assistance.

- State projects under construction
  - Route 51 (Otsego Street) over Steele Creek bridge replacement in the Village of Ilion, \$3.8 million, constructed by Rifenburg. The installation of the bridge substructure is underway with the setting of steel before Labor Day. The project is estimated to be completed in December.
  - Route 5s over Route 51 Deck Replacement in the Village of Ilion, \$1.6 million, constructed by Slate Hill. There will be a new traffic pattern for phase 2 of the deck replacement with an estimated completion set for late Fall.
  - Route 26/365 Safety & Pavement Project in the City of Rome, \$6.7 million, constructed by Hanson. The project is anticipated to be substantially complete in 2022 but has faced setbacks due to delays in obtaining high mast lighting.
  - Route 825 Bridge Rehabilitation in the City of Rome, \$2.6 million, constructed by Tioga. The current closure is scheduled to be opened by the end of September with a completion set for November.
  - Route 8 over 5 & 12 Bridge Replacement, \$12 million. The project is expected to be complete in Fall 2022.
  - Local project Middle Settlement Road in the Town of New Hartford, \$4 million, constructed by CCI. The identification and relocation of utilities is causing some delays. The project is expected to be completed in 2023.
  - Local project Oneida Street over Sauquoit Creek, \$1 million, constructed by DH Smith. Utility relocation has caused some delays. The project is expected to be complete in 2023.
  - Local project Mohawk River Trail, Phase 2, City of Rome, \$1 million. The project is currently progressing.
  - Willow Place TAP Award in the Town of Verona is currently in the design approval phase of the project.
- O David Wood poses a question regarding the 840 Bridge and when it is to be completed. Anthony Picente replies that he spoke with Matt Driscoll and that he had initially indicated it will be completed in the Spring. However, Picente had heard from the contractors on the project that the bridge would not be completed until July. Picente is still awaiting to hear back from Driscoll.

#### Other Reports

- New York State Thruway Authority
  - Todd Gold gave the following report on behalf of NYSTA:
    - NYSTA is currently pursuing grant opportunities, stating that they were not as fortunate this round as NYSDOT was, but that they hope they will do better in the future.
    - Gold states that he is aware of the extensive questions posed toward the Exit 31 PEL project. NYSTA will review the scope of work when that becomes available and that they want to assist when needed.
    - John Piseck states that he is interested in how the Herkimer County IDA can progress infrastructure at the three rest areas located in Herkimer

County. Gold replies that typically the NYSTA doesn't typically act as a utility but that he will review any proposals.

#### Presentations

- TIP 2023 2027
  - Dana Crisino gave the following presentation:
  - The TIP is a five-year capital program that identifies transportation improvements that have funding to advance. These improvements include realistic estimates of total costs and funding that incorporate LRTP, UPWP, statewide, and federal priorities. The TIP is fiscally constrained and is also included in the Statewide TIP. Furthermore, the TIP is required for federally funded projects and is IIJA/BIL compliant.
  - The process for the development of the TIP includes solicitation of potential project proposals from MPO municipalities and agencies. Next, a review of available funding sources and directions provided by NYSDOT occur. An illustrative project listing is developed from the solicitation with a review of the draft performed with NYSDOT Region 2.
  - NYSDOT Main Office is provided a copy of the draft for fiscal review. Completion
    of the self-certification process then occurs, followed by a release of the draft for a
    30-day public review period. TPC and GP&L review the comments received and
    then formally adopt the plan.
  - The TIP contains the following: overview of HOCTC, TIP programming instruction, TIP development, community participation, project selection process, and changes to the TIP. Additionally, the project funding categories of highway, transit, and other are listed along with funding sources, illustrative highway and bridge projects, and FHWA/FTA transportation performance management.
  - Revisions to the TIP can be made at any time under procedures that have been adopted by the state, MPO, and public transit operator. These include: amendments, administrative modifications, and written justifications.
  - Highway funding sources for the TIP include: HSIP, HSIP Rail, NHPP, STBGP Flex, STBGP LG Urban, STBGP-Off, NHFP, SDF, BFP, CRP, NEVI, TAP, RHCP, and MPP.
  - Transit funding sources include: FTA Sections 5307, 5309, 5310, 5311, 5312, 5314, 5324, 5339.
  - The TIP has programmed highway funds in the amount of \$210.2 million for FFY 2023 2027 (NHPP \$81.31 million, HSIP \$18.77 million, STBGP Flex \$90.17 million, STBGP-Off \$13.94 million, and \$6.00 million for NHFP).
  - Transit has been funded at \$43.28 million for FFY 2023 2027 for the TIP (5307 \$6.380 million, 5310 \$1.085 million, 5311 \$0.725 million, and 5339 \$35.09 million).
  - Blocked local projects have been programmed in the amount of \$35.52 million for FFY 2023 2027 (2TLB21 \$0.974 million, 2TLB25 \$2.000 million, 2TB261 \$1.881 million, 2TP251 \$7.829 million, 2TP261 \$11.34 million, and 2TP271 \$11.50 million).
  - MPOs must employ a transportation performance management approach that includes the following national performance goals for the Federal-Aid Highway Program to include: safety, capital assets condition, congestion reduction, system

- reliability, freight movement & economic vitality, environmental sustainability, and reduced project delivery delays.
- Concurrent with the submittal of the proposed TIP to FHWA and FTA as a part of the STIP approval, MPOS shall certify that the metropolitan planning process is being carried out in accordance with all applicable requirements to include: UPWP, LRTP, TIP, technical studies and emphasis areas, Title VI, environmental justice, private operators, planning factors, congestion management process, public involvement, progress reports, bills paid, audits, annual work program, MPO budget, central staff/host relations, decision making, governance, procurement, and project management.
