## **HOCTS Resolution 2020 - 03b**

Amendment to the 2020 – 2024 Transportation Improvement Program (TIP) for the Utica Urbanized Area to revise an existing project on the project listing.

**WHEREAS**, the Governmental Policy and Liaison Committee (GP&L) has previously approved the 2020 – 2024 TIP; and

**WHEREAS**, a TIP amendment is required when PIN numbers for State or Federal Aid funded projects are revised on the existing project list; and

NOW, THEREFORE BE IT RESOLVED, that PIN 280600 – Culvert Repair/Replacement Project 19 shall have an increase in STP Flex funding, for the construction and construction inspection phases, in the amount of \$439,000 for FFY 2021; and

**BE IT FINALLY RESOLVED**, that the Governmental Policy and Liaison Committee hereby directs the Chairman to communicate this action to the appropriate State and Federal officials in the prescribed manner.
