HOCTC Resolution 2021 - 24

Amendment to the 2021 – 2022 Unified Planning Work Program (UPWP) Budget

- WHEREAS, the FAST ACT authorized the use of funds for Metropolitan Planning Organization's to carry out transportation planning requirements and responsibilities; and
- WHEREAS, Federal regulations (23 CFR Chapter 1, Part 450, Subpart C, and 49 CFR Chapter VI, Part 613, Subpart B) require that the urban transportation planning process shall include development of a Unified Planning Work Program (UPWP) which shall annually describe all urban transportation and transportation related planning activities anticipated within the next one year period, and will document the work to be performed with technical assistance provided under the Fixing Americas Surface Transportation (FAST), Title VI, Section 5303 Program; and
- **WHEREAS**, HOCTC developed the 2021 2022 UPWP and budget through the continuous, comprehensive, and cooperative transportation planning process in coordination with state, regional, and local agencies and officials; and
- **WHEREAS**, the 2021 2022 UPWP was legally advertised for public review in accordance with HOCTC PPP and all applicable regulations; and
- WHEREAS, the 2021 2022 UPWP was approved on February 23, 2021 by HOCTC Resolution 2021 1 of the Governmental Policy & Liaison Committee; and
- **WHEREAS**, the 2021-22 UPWP programed an estimated \$450,000 in FHWA PL backlog/savings from the 2020-21 program years, where actual expenditures resulted in a backlog/savings of \$283,098 in FHWA PL; and
- **WHEREAS**, FHWA PL funds programmed are to be reduced in the project, task, contractual budgets to accurately reflect the current backlog/savings available; and

- NOW THEREFORE BE IT RESOLVED, that the UPWP 2021-2022 budget shall be amended as shown in the attached budget; and
- **BE IT FURTHER RESOLVED**, that the Governmental Policy & Liaison Committee authorizes the Transportation Planning Committee to make necessary schedule revisions, project refinements, and give task specific direction to HOCTC staff to carry out this work program during the course of the year; and
- **BE IT FURTHER RESOLVED,** that the Governmental Policy and Liaison Committee for HOCTC certifies that the requirements of 23 CFR Part 450.114 (c) have been met; and
- **BE IT FURTHER RESOLVED**, that the Governmental Policy and Liaison Committee approves the amended budget for the 2021 2022 UPWP Budget, as shown in the attached tables; and
- **BE IT FINALLY RESOLVED**, that the Governmental Policy and Liaison Committee hereby directs the Chairperson to communicate this action to the appropriate State and Federal officials in the prescribed manner.

HOCTC Resolution 2021 – 26

2022 Traffic Safety Performance Measures Targets

- WHEREAS, the Herkimer-Oneida Counties Transportation Council has been designated by the Governor of the State of New York as the Metropolitan Planning Organization responsible for the comprehensive, continuing, and cooperative transportation planning process for the Herkimer-Oneida County Urbanized and approved Metropolitan Planning Areas; and
- **WHEREAS**, the Highway Safety Improvement Program (HSIP) final rule (23 CFR Part 490) requires States to set targets for five safety performance measures; and
- **WHEREAS**, the New York State Department of Transportation (NYSDOT) has established targets for five safety performance measures based on five year rolling averages for:
 - (1) Number of Fatalities,
 - (2) Rate of Fatalities per 100 million Vehicle Miles Traveled (VMT),
 - (3) Number of Serious Injuries,
 - (4) Rate of Serious Injuries per 100 million VMT, and
 - (5) Number of Non-Motorized Fatalities and Non-motorized Serious Injuries; and
- WHEREAS, the NYSDOT coordinated the establishment of safety targets with the fourteen Metropolitan Planning Organizations (MPOs) in New York through the New York State Association of Metropolitan Planning Organizations (NYSAMPO) Safety Working Group, the NYSAMPO Fixing America's Surface Transportation (FAST) Act Working Group, discussed the targets at a Federal Highway Administration (FHWA) Safety Target Setting Workshop, and during an Executive Director's meeting; and

- WHEREAS, the NYSDOT incorporated the safety targets in the Highway Safety Annual Report due to the Federal Highway Administration, and the Governors Traffic Safety Committee has adopted identical safety targets for number of fatalities, rate of fatalities and number of serious injuries as set forth in the Highway Safety Strategic Plan (HSSP); and
- NOW, THEREFORE BE IT RESOLVED, that the Governmental Policy & Liaison Committee agrees to support NYSDOT's 2022 targets for the five safety performance targets as attached herein; and
- **BE IT FURTHER RESOLVED**, that the Governmental Policy & Liaison Committee will plan and program projects that contribute to the accomplishment of the safety targets; and
- **BE IT FINALLY RESOLVED**, that the GP&L Committee hereby directs the Chairman to communicate this action to the appropriate State and Federal officials in the prescribed manner.
