2. Approval of the Minutes

3. Public Comment

- **4. Director's Report -** Julie Richmond, HOCTC Director, gave a synopsis of HOCTC activities for the past quarter.

SS4A – The Oneida Herkimer County Safety Action Plan

- The final plan should be ready before the next TPC meeting. The plan will be based on the Safe Systems Approach.
- The Transportation Safety Summit took place on November 19, 2024. Several of
 the issues raised mirrored those raised during the other public engagement events,
 such as connectivity, sidewalk infrastructure, dangerous intersections, freight and
 hazardous materials, agricultural traffic, winter concerns, and public transportation
 infrastructure.
- What was presented at the Safety Summit is in two tracks, a proactive and reactive approach, representing both programmatic and infrastructure type improvements.
 - The Safety Action Plan will focus on ten priority locations for infrastructure improvements. The consultant team has identified 10 intersections and 10 segments that participants were asked to help narrow down and asked what they would like to see at these locations.
 - Proven safety countermeasures for intersections were given as an example of what should be in the toolbox portion of the plan for specific sites that can be replicated for sites with similar features.
 - o These locations will not be the only locations that can be funded but will be provided as examples of what can be done at a typical location.
 - o Programmatic recommendations will also be given in the Plan.
- The Safety Action Plan will also identify funding sources. Oneida and Herkimer Counties received a grant for planning funding. Once the Safety Action Plan is adopted, the counties or any municipality within the two counties can apply for implementation funding. It is anticipated that NOFO for Implementation Funding will be released in March 2025.
- A question was asked about the expectation for full funding for projects or if there will be a local match and/or county funds applied.
 - There is not yet enough program detail regarding the implementation funding to know how the implementation funding application(s) will work.
 It will depend on what the guidance allows and who has jurisdiction over

the roadway and how the two counties, collectively, want to address that. Exit 31 Planning and Environment Linkages Study

- There will be an open house held on December 3, 2024. The open house will be higher level since the concepts are still under review. The study area will be sectioned by north, south, and Exit 31.
- Five concept opportunities for the study area have been developed with varying levels of intervention, including a no-build option.
 - The concepts are based on items identified in the Purpose and Need statement.
- The study team is launching a public survey to ensure the public is in agreement with the direction the study is moving in.

Transportation Improvement Program (TIP)

- The HOCTC TIP is due for its update. The update process will begin after the GP&L meeting in December.
- The TIP is the five-year capital improvement project listing for which federal funds are anticipated. It identifies the funding and timing of the projects and allows for changes in priorities, which is done at each of the TPC meetings.
- A call letter will go out to everyone requesting projects and will require a response by March.

The Unified Planning Work Program (UPWP)

- The UPWP is updated annually and allocates planning funds for HOCTC.
- Allocations should be released soon.
- Everyone will also be receiving a call letter for the UPWP shortly after the GP&L meeting since the deadline is sooner than the TIP.

NYSAMPO 2025 Conference

- The conference is being held in Syracuse May 13-14, 2025.
- HOCTC will be presenting on SS4A and the Exit 31 PEL Study at the conference.
- It is a great opportunity for networking and a great training opportunity for best practices and case studies.
- **5. NYSDOT Region 2 Report** Deborah Windecker, NYDOT gave a synopsis of Region 2 activities this past quarter.
 - Every three years, DOT does a capital program plan for 5 years 2025-2030 for the TIP and 4 years for the STIP 2025-2029.
 - A new TIP report is created providing various funding sources, this year through the Bipartisan Infrastructure Law (BIL), which expires in 2026.
 - Will identify projects using engineering-based asset management to improve bridge and pavement scores, address climate resiliency and vulnerabilities, reduce transportation carbon footprint through active transportation, which is addressed through the Carbon Reduction Program (CRP), want multi-modes of usage for all, efficiency in the whole system including emergency response.

- NYSDOT Region 2 allocations: The Bridge Formula Program (BFP) constitutes 48% of funding and is a newer source.
- There is a heavier focus on bridges since they were all built around the same time and all are coming up on needing replacement.
- Region 2 would like to continue the BridgeNY program in the current way by distributing funding through MPO process.
- o There is also a heavier focus on road safety since New York State is not ranking well in fatalities and serious injuries.
 - Region 2 will allocate 25% (\$4.2M) of Highway Safety Improvement (HSIP) money to local roads to tie in with the SS4A grant.
- The \$10M in Off-System Bridge (OSB) allocated to HOCTC funding does not include culverts. This funding can be used for bridge demolition. If someone has a specific bridge, contact the DOT to start the process.
- Carbon Reduction Program (CRP) can assist with adding sidewalks to areas in need.
- The Bridge Formula Program funding can be easily spent since the cost of everything is so high.
- West German Street over Bellinger Brook, a BridgeNY 2018 project should be complete by the end of November.
- N. Genesee Street Safety Project is moving forward with the DOT adding a second lane on the off-ramp to I-90/I-790.
 - o There is a delay in the signal pole so the lane will not open until the signal is activated at the convergence of the ramp and N. Genesee St.
 - o The project cost is \$2.4M
- Route 12 Boonville Safety Project is progressing but there are supply chain challenges, especially with signal poles. The signal will not be installed until 2025.
 - The project cost is \$2.4M.
 - o The plan is to install metal signal poles but cannot get the materials at this time.
 - A question was asked if the signal pole shortage is a result of the hurricanes in the South.
 - This was an issue before hurricane season.
- Route 46 over Oneida Creek in the City of Oneida in Madison County and the Town of Verona in Oneida County has a cost of \$8.8M.
 - o This project will be complete by the end of 2024.
- The Boonville Route 12D Paving Project, along with Route 12D/294/46 was let in August and has a construction cost of \$2.8M.
 - o There are complications with this project due to the lead pipe initiative.
 - o There will be six miles of paving in the Village of Boonville, half a mile of sidewalk, crosswalk enhancements, and 24 ADA ramps.
- Clinton Route 12B Paving project for Routes 12B and 412, Oneida County is a two-season project at a construction cost of \$8.3M.
 - o 6.9 miles of pavement rehab, signal improvements, sidewalk extensions, sanitary improvements, and hydrant replacements.

- The DOT has been working with the Village of Clinton for a betterment of over \$1M.
- W. Main Street over Moyer Creek bridge in the Village of Frankfort, which is a 2018 BridgeNY and was re-let in November 2024 for a cost of \$5.9M.
 - o There has been a tremendous cost increase for this project.
 - o It is the goal of Region 2 to move these projects along.
 - A question was asked if any policy regarding the impending tariffs is in place. There is not at this time.

6. NYS Thruway Report - Sara Sherlock, NYSTA gave a synopsis of the activities undertaken by NYSTA this past quarter.

- Several projects are wrapping up for the winter.
- Ongoing projects include Pavement resurfacing, which will be completed by the end of 2024,
- Mainline bridge rehabs over Sterling Creek, scheduled to be complete in Winter 2025.
- Thruway bridge replacement over Oriskany Blvd. with a scheduled completion of Winter 2026.
 - Oriskany Blvd. traffic pattern will change in the spring. HOCTC would like to know if there will be any road closures or what the impact will be. NYSTA will verify and get back to HOCTC.
- 2024 tentative project Replacement of Thruway bridge over Mohawk St. (Route 28) with a Winter 2026 completion.
- 2025 Tentative Projects include the Rehab of N. Genesee St. away bridge,
- Replacement of Route 46 Bridge over the Thruway in Durhamville, and
- Safety upgrades for the same section that was just paved.
- Comments and questions
 - o The DPW stated that NYSTA was interested in the old buildings off Route 31 and how they could be offloaded to NYSTA. They can look into a permit or rental since it is no longer occupied and there can possibly be an access permit granted. NYSTA will get back to DPW.
 - o NYSTA is working on comments for the PEL Study.

7. Other Reports –

• This is not a report but an informational update. Oneida County emails and the website domain have changed from ocgov.net to oneidacountyny.gov. Herkimer County has already updated its domain as well.

8. Presentations –

Steve Koegel, Centro gave a synopsis of the activities that have taken place at Centro in 2024.

- Centro will begin installing solar signage at bus stops with real-time updates and lighting. This will start at bus shelters and then spread to other stops.
 - There is currently an RFP for the solar signage/lighting and Centro hopes to begin work in the Spring, starting with its hubs.

- This will provide some safety features on a pole with a solar panel and light on top.
- Centro will be site planning for smaller units throughout Utica. The City of Utica suggested that the Broad Street TAP grant remodel could be a good place to start.
- The Rural Transit Service UT33 is going well. Centro had to add larger vehicles to the route, primarily for recreational users on Fridays and Saturdays. There has been a steady increase in ridership since its launch in October 2024 from around 100 to almost 300 riders per week.
 - O There has been a request for a deviation from Route 49, which would make it difficult to keep time. Deviating the service significantly increases the risk that users cannot make connections at the Centro transit hubs in Utica and Rome. There is no good turnaround at the Psychiatric Center, but it is a half mile walk for the rider.
 - o Ridership will be assessed in the Spring. Some routes or stops may not be being used and then can reallocate resources elsewhere.
- Centro's MOVE flexible option in Rome is outperforming the six routes that were previously there.
 - The cross-section of users is expansive, and the service is more expansive, serving where Centro has not been serving.
 - o Almost all are satisfied with the service, leaving multiple 5-star reviews.
 - o This program provides services in locations that were not offered before.
 - o The service is 200-250 riders per week as well.
 - o This service utilizes VIA Technology, the same as in Oswego County for their app-based services. VIA is the top on-demand service in the country.
 - Ridership in Rome is way up since COVID and up about 18% throughout Oneida County.

John Duesing, Transpo Group, Inc. gave a presentation on the HOCTC 2025-2045 Long Range Transportation Plan: Going Places 2045 to recommend for adoption.

- An overview of the process required for approval of the plan by December 31, 2024, was provided.
- The 2019 process for 2020-2040 was a complete revamp of the Long Range Transportation Plan, so Going Places 2025-2045 is the first update from that.
- Currently, HOCTC and the consultant team are on the 8th and final step of refining the plan based on feedback.
- Trends
 - Construction cost inflation was a surprising national trend from the pandemic.
 - There has been a 19% increase in truck traffic since 2019 in the HOCTC region.
 - o Population and household sizes remained relatively constant.
- Some changes focused on in this update were developing new, broader goals to include in all projects. Linkages to land use planning is an important one.
- Public Engagement

- o HOCTC staff participated in approximately 30 in-person pop-up events and three public open house-style meetings.
- o The public was offered an in-person engagement budget exercise, access to a survey, and an exercise asking their primary mode of transportation.
- One of the key takeaways is that people are concerned with road maintenance since most people rely on private vehicles for transportation.
- o Sidewalk improvements/additions, accessibility, and safety also ranked high importance in all public engagement efforts.
- Passenger rail came up as important quite often. Some people are looking for quick connectivity between local cities. More routes to Syracuse and Albany were also requested.
- Financial Analysis looking at 2028-2045 programming needs and already programmed items in the 2023-2027 TIP. The plan looks at the state of good repair first.
 - o The Bipartisan Infrastructure Law (BIL) helped with new funding sources.
 - o If the same levels of funding continue, HOCTC may be able to add illustrative projects.
 - There is a disconnect with maintenance funding and DEC regulations that are being enacted requiring additional maintenance; Right-sizing culverts, for example.
- Projects Some of the projects include supplemental LRTP work.
 - o A freight study whereas freight activity is discussing the movement of goods via truck.
 - o There will also be an Atlas update, which was a new component five years ago. It is a long executive summary and won a national award.
 - o A big push through the FHWA is planning for complete streets, which is embedded in every plan.
 - The EV Charging infrastructure could use upgrades since there are not many in the area at this time. The parking garage should have 69 stations active soon.
 - o HOCTC will be updating its EV charging station plan since Oneida County will be installing charging stations.
 - Any project is illustrative until it is allocated funding. This is addressed via the needs assessment.
 - For transit projects, the expansion of Centro's MOVE service in Rome is on the list, as is mobility management coordination, and transit facility consolidation.
 - The need for transit options in Herkimer County is also a priority and was brought up often at public engagement events in Herkimer County.

10. New Business – HOCTC Resolutions 2024-35 – 2024-48

2024-35 – HOCTC 2025-2045 Long Range Transportation Plan "Going Places 2045", *Presenter: Julie Richmond, HOCTC*

- The TPC served as the TAC for this Plan update. This resolution is seeking a recommendation for approval to adopt the LRTP, following Title 23, Section 134 and in accordance with HOCTC's 2024 Public Participation Plan has been found to afford a public participation process that ensured equal opportunity for public involvement of all persons in the transportation planning process.
- The LRTP has been developed and revied by HOCTC staff, member agencies, and the HOCTC committee processes and its recommendations have been found to be consistent with the principles of sound transportation planning practices.
- Discussion: None

2024-36 - Amendment to the HOCTC 2025-2028 Human Services Transportation Plan (HSTP) to update Appendix F – Annual Listing of Section 5310 Projects,

Presenter: Barbara Hauck, HOCTC

- The current federal transportation bill, Infrastructure Investment and Jobs Act (IIJA) of 2021 upholds and expands previous transportation legislations that require a locally developed, public transit and human services coordinated plan to be developed and maintained.
- The HOCTC Human Services Transportation Plan (HSTP) 2025 2028 was approved by the GP&L on September 12, 2024.
- This coordinated plan needs to be in place for the eligibility of the Section 5310 Program, the Enhanced Mobility of Seniors and Individuals with Disabilities. A further provision of the Section 5310 program requires that funding applicants have their potential projects included in the HSTP.
- Agencies who submitted Section 5310 potential projects for 2024 and included in Appendix F are:
 - o Katherine Luther Residential Health Care & Rehabilitation Center
 - o ElderLife, Inc. (d/b/a 50 Forward Mohawk Valley)
 - o NYSARC, Inc. Oneida-Lewis Chapter
 - Senior Network Health, LLC
 - o Herkimer County Chapter of NYSARC, Inc.
 - Senior Citizens Council Rome NY, Inc. (d/b/a Copper City Community Connection)
- The Resolution is requesting approval to add the six project proposals to Appendix F of the HSTP.
- Discussion: None

2024-37 – Amendment to the 2023-2027 TIP to remove a Culvert Preventative Maintenance Project, *Presenter: Mark DeRocco, NYSDOT*

- Description: PIN 2806.96 Small Culvert/Preventative Maintenance Project 25 involves various locations regionwide.
 - o The project amount of \$2.187M with STBG Flex and NHPP funds shall be removed from the TIP
- Discussion: None

2024-38 – Amendment to the 2023-2027 TIP to remove a Culvert Preventative Maintenance Project, *Presenter Mark DeRocco*, *NYSDOT*

- Description: PIN 2806.97 Small Culvert/Preventative Maintenance Project 27 involves various locations.
 - The total project cost of \$2.260M in federal STBG Flex and NHPP funds shall be removed from the TIP.
- Discussion: None

2024-39 - Amendment to the 2023-2027 TIP to revise a Bridge Replacement Project, *Presenter: Mark DeRocco, NYSDOT*

- Description: PIN 2754.76 Gridley Paige Road over Big Creek (BIN 2205850) bridge replacement in the Town of Marshall, Oneida County.
 - O This project will be revised as follows: the project will be increased by \$0.370M from \$1.169M to \$1.539M with leftover STBG Off-System funds from three completed projects within Oneida County, PINS 2754.40, 2754.43, and 2754.44.
- Discussion: None

2024-40 - Amendment to the 2023-2027 TIP to add a Pavement Replacement Project, *Presenter: Mark DeRocco, NYSDOT*

- Description: PIN 2067.03 Route 825: Route 49 to Geiger Road/Ellsworth Roundabout to modify approaches and potentially alter the circular pavement of the roundabout at Ellsworth Road in the City of Rome, Oneida County. The modifications would bring the road up to current design specifications to reduce vehicle approach speeds.
 - This project will be funded in the amount of \$5M with NHPP funds. The funding comes through freight program funds.
- Discussion: None

2024-41 - Amendment to the 2023-2027 TIP to revise an Intersection Improvement Project, Presenter: Mark DeRocco, NYSDOT

- Description: PIN 2806.52 Route 46/Wright Settlement Road intersections from North James Street to the first driveway of the Ridge Mills School along Route 46.
 This involves improvements in traffic control devices and/or minor geographic improvements in the City of Rome, Oneida County.
 - The total project cost will increase from \$0.962M to \$1.767M using NHPP funds.
 - Changed from NHPP to Safe Routes to School funding but felt it prudent to add the NHPP funding back in based on the scope of the project.
- Discussion: None

2024-42 – Amendment to the 2023-2027 TIP to revise a Bridge Rehabilitation and Culvert Replacement Project, *Presenter: Mark DeRocco, NYSDOT*

- Description: PIN 2754.97 This project will rehabilitate the bridges that carry Dyke Road (BIN 3366130) and Bleecker Street Extension over Ferguson Creek (BIN 3366140) in the Town of Frankfort, Herkimer County.
 - The original project included a BridgeNY culvert. That culvert is being pulled out of this PIN and given its own PIN (2755.11), which will be 100% State funded. This will not be listed on the S/TIP.
 - o The project will also be removing 100% SDF Construction and moving the Bleecker Street Culvert Site to its own project (PIN 2755.11).
 - o The total project cost for PIN 2754.97 will be reduced by \$1.497M from \$3.361M to \$1.864M.
- Discussion: None

2024-43 – Amendment to the 2023-2027 TIP to add a Pavement Replacement Project, *Presenter: Mark DeRocco, NYSDOT*

- Description: PIN 2807.39 R2 multi-site paving project 24 to resurface and improve pavement at several locations in Oneida and Madison Counties.
 - The project will be funded in the amount of \$6.96M with NFA and NHPP funds.
- Discussion: None

2024-44 – Amendment to the 2023-2027 TIP to revise a Bridge Replacement Project, Presenter: Mark DeRocco, NYSDOT

- Description: PIN 2236.27 This project will replace the bridge carrying New York State Route 29 over East Canada Creek (BIN 1051170) in the Village of Dolgeville, Herkimer and Fulton Counties. This project will address issues with bridge width, vertical clearance, bridge alignment, resiliency, and the intersection with Route 167 on the western approach of the bridge.
- Project revisions include a cost increase of \$15.80M (\$5.0M in Freight funds and \$10.80M in PROTECT funds) from \$10.880M to \$26.80M that is outside of core funds.
- Discussion: None

2024-45 - Amendment to the 2023-2027 TIP to revise Traffic Safety Enhancements, *Presenter: Mark DeRocco, NYSDOT*

- Description: PIN 2806.93 Route 365/River Road Intersections Improvement Project will provide safety enhancements for pedestrians and motorists in the City of Rome, Oneida County. Elements may include pedestrian signal upgrades, striping, and/or lane configuration.

- WHEREAS, HOCTC staff developed the 2025 2026 UPWP through the continuous, comprehensive, and cooperative transportation planning process in coordination with state, regional, and local agencies and officials; and
- WHEREAS, the Transportation Planning Committee and Governmental Policy & Liaison Committee have worked with HOCTC staff to develop a recommended UPWP so that the latest draft submitted herewith represents an accurate description of work to be undertaken and funds to be made available; and

- **WHEREAS**, the 2025 2026 UPWP was legally advertised for public review in accordance with the HOCTC Public Participation Plan and all applicable regulations, with the review period closing on February 14, 2025; and

- **BE IT FURTHER RESOLVED**, that the Governmental Policy and Liaison Committee authorizes transmittal of this 2025 2026 UPWP to the NYS Department of Transportation to be used for an application to the Federal Transit Administration to obtain transit planning funds on behalf of HOCTC; and

- (4) Rate of Serious Injuries per 100 million VMT, and
- (5) Number of Non-Motorized Fatalities and Non-motorized Serious Injuries; and

WHEREAS, the NYSDOT coordinated the establishment of safety targets with the fourteen Metropolitan Planning Organizations (MPOs) in New York through the New York State Association of Metropolitan Planning Organizations (NYSAMPO) Safety Working Group, the NYSAMPO Fixing America's Surface Transportation (FAST) Act Working Group, discussed the targets at a Federal Highway Administration (FHWA) Safety Target Setting Workshop, and during an Executive Director's meeting; and

- WHEREAS, the NYSDOT incorporated the safety targets in the Highway Safety Annual Report due to the Federal Highway Administration, and the Governors Traffic Safety Committee has adopted identical safety targets for number of fatalities, rate of fatalities and number of serious injuries as set forth in the Highway Safety Strategic Plan (HSSP); and
- NOW, THEREFORE BE IT RESOLVED, that the Governmental Policy & Liaison Committee agrees to support NYSDOT's 2025 targets for the five safety performance targets as attached herein; and
- **BE IT FURTHER RESOLVED**, that the Governmental Policy & Liaison Committee will plan and program projects that contribute to the accomplishment of the safety targets; and
- **BE IT FINALLY RESOLVED**, that the GP&L Committee hereby directs the Chairman to communicate this action to the appropriate State and Federal officials in the prescribed manner.

NYS SAFETY TARGET SETTING METHODS – 2025 TARGETS

NYS Department of Transportation, Office of Traffic Safety and Mobility

Overview

As per the Highway Safety Improvement Program final rule (23 CFR Part 490); States are required to set targets for five safety performance measures. The measures are the 5-year rolling averages for:

- Number of Fatalities*
- Rate of Fatalities (Fatalities / 100M VMT) *
- Number of Serious Injuries*
- Rate of Serious Injuries (Serious Injuries / 100M VMT)
- Number of Non-motorized Fatalities and Non-motorized Serious Injuries

MPO Requirements

MPOs establish safety targets by either:

- Agreeing to plan and program projects that contribute toward the accomplishment of the State DOT target or
- Committing to a quantifiable safety target for the metropolitan planning area.

Timeline

- GTSC reports targets in the HSP.
- NYSDOT establishes safety targets in the HSIP annual report on August 31, 2024.
- MPOs must agree to support state targets or establish their own within 180 days of the State establishing and reporting its safety targets. The MPO targets are due February 28, 2025.





RE: HOCTC TIP 2023 – 2027: Administrative Modifications (January 2025- February 2025)

An Amendment, in the form of an Administrative Modification (Admin. Mod.) is made to the Transportation Improvement Program (TIP) when revisions of cost changes of \$549,999 or less, an increase in the total cost of the project is less than 10% or when there is a change in funding year for any phase of an existing PIN project. An Admin. Mod., as per HOCTC TIP procedures, require approval from the NYSDOT Region 2 RPPM and the HOCTC Program Manager. Joint approval is issued in the form of a jointly signed letter, which is addressed to the NYSDOT Region 2 Director, notifying them of the Admin. Mod. and agreement of the two agencies regarding the action to be taken on the TIP. In an effort to ensure transparency, the following table is a record of the Admin.
