**4. Director's Report**

*HOCTC Director, Julie Richmond gave a synopsis of HOCTC activities for the past quarter.*

Transportation Atlas

- HOCTC has completed their Transportation Atlas. The Atlas is a visual representation of HOCTC's Long Range Transportation Plan (LRTP) Going Places 2045. The purpose of the document is to be a user-friendly resource for the public and elected officials which highlights Herkimer and Oneida County's history, existing conditions, and future path. It is all based on the data collected during the update to the LRTP and provides a snapshot in a graphic format that complements HOCTC's planning efforts and those of our planning partners. It is updated immediately following the adoption of the LRTP, which is a 5-year cycle.

## Exit 31 PEL Study

- The last several months have been reserved for the review of the concept screening process, selection of the final two concept alternatives, supporting the Technical Memorandums and the supporting analysis that goes along with them. The consultant team is finalizing this review phase in the coming weeks with a final email being circulated to the agency stakeholders as the last call on comments.
- While the review has been underway, the consultant team are advancing work on the 2D visuals.
- The project schedule has been revised slightly. It is anticipated that the final draft report will be presented to HOCTC around March. NYS DOT and FHWA final review will be in April. The tentative final TAG meeting will be mid-June with a final public meeting shortly following in late June.

## HOCTC LRTP Add-on Task: Freight Analysis Memo

- When HOCTC completed the Long-Range Transportation Plan update, one of the outcomes and recommendations was to take a closer look at freight. As a result, HOCTC has conducted a freight network analysis task with assistance from Cambridge Systematics and Transpo Group.
- The primary objective of the freight and truck analysis task revolved around evaluating and identifying the needs for improving the network within the planning area. It involved assessing the current state of the freight network by conducting a comprehensive review of the region's existing conditions and then analyzing both current and future transportation needs, considering factors such as demand trends, growth projections, and evolving industry requirements.
- HOCTC conducted interviews with regional economic development stakeholders, and the agricultural community, to discuss the current and future needs of these industries. Their input was incorporated into the analysis.
- The final report, or technical memorandum details freight demand drivers, directional flow, supply chain operations within the broader logistics industry and determines how these sorts of dynamics will influence freight movement in the region today and in the future. It also outlines recommendations and identifies both short- and long-term policy and capital improvements and the assigned stewards for implementation.
- The final draft of the content of the Technical Memorandum is complete; it has been formatted by the consultant team. HOCTC has slowly started to circulate the final product to the planning and policy committee members, as well as the stakeholders who participated in the interviews. It is currently available to view on the [LRTP ArcGIS Hub website](#). A full summary of the findings will be presented at the June meeting.

## 2026 – 2027 Unified Planning Work Program (UPWP)

- The UPWP is a document that is updated annually. It's the planning component of the funding HOCTC receives. HOCTC receives both FHWA PL funds and FTA MPP funds.
- The purpose of the UPWP is to direct the daily operations of the MPO and delivery of transportation planning. It helps HOCTC move towards implementing the LRTP goals.

HOCTC ensures all modes of travel are included and it provides a forum for the community to have input, it aligns with regional development goals with transportation investments, and it utilizes data and analysis to support transportation planning.

- HOCTC works to achieve LRTP and TIP goals through interim planning in the annual UPWP to carry out the continuing, cooperative, and comprehensive transportation planning process.
- For this UPWP there are a few things to note: Federal Fiscal Year 2026 is the final year of the IJJA, which is set to expire September 30, 2026. This matters because:
  - Federal surface transportation reauthorization is the process Congress uses to renew, fund, and update the programs that build and maintain the nation's roads, bridges, transit, and multimodal networks.
  - Reauthorization is one of the most important tools Congress has to shape national transportation policy. Typically, transportation legislation is passed every five to six years. These bills establish funding levels, define federal priorities, and guide how transportation investments are made.
  - These decisions influence which types of projects are eligible, what outcomes are prioritized (such as safety, mobility, economic development, etc.), and how regions access and manage federal dollars.
  - As an example of how this impacts us at municipal level, HOCTC was advised by NYSDOT Main Office and FHWA representatives to remove the joint FHWA and FTA planning Priority Emphasis Areas set forth in IJJA, from the UPWP narrative. The PEA's included:
    - Tackling the Climate Crisis, Advancing Racial Equity, Evaluating the impact of Complete Streets, increasing meaningful Public Involvement, Coordination with federal agencies on connectivity for public roads that connect to Department of Defense facilities or Federal Lands, Environmental Review Process, and Transportation Data Sharing.
  - These emphasis areas have been removed from the UPWP, and we are in a holding pattern until the new surface transportation bill is passed and we get guidance on what the current administration's emphasis areas will be.
  - HOCTC received further guidance after the UPWP was drafted advising MPOs to remove reference to rescinded executive orders that referenced Environmental Justice and refer only to NYS guidance on environmental justice requirements. HOCTC will continue to periodically conduct demographic analysis, but it will be called a Non-Discrimination Demographic Analysis.
- Some highlights of what was completed in the 2025-2026 Planning State Fiscal Year are:
  - Long Range Transportation Planning
    - Transportation Atlas update finalized.
    - Freight Planning – Technical Memo was created and will have more on that at the next meeting.
    - Bicycle, Pedestrian, and Non-Motorized Transportation Systems – Story Map was created.
    - HSTP Implementation – Established a Regional Mobility Coordination Council.
  - TIP Update and Maintenance
    - Adopted the 2025-2029 TIP in June 2025

- Program Support and Administration
  - Environmental Justice/Title VI Analysis update which will be renamed to ‘Non-Discrimination Demographic Analysis/ Title VI Policy’
- New tasks have been added to the UPWP:
  - Housing and Community Planning Task was added. This task is to examine the need for affordable housing and jobs, which intersects with transportation, infrastructure, safety, complete streets, planning and multi-modal connectivity as it relates to accessing jobs. HOCTC has a few projects currently underway working toward implementing the Oneida County Housing Study and Cornhill Public Realm Improvement Plan.
  - Regional Sidewalk Inventory Task was added. HOCTC is working in cooperation with the NYSDOT Region 2 office in undertaking a pilot mapping study of all sidewalks and multi-use paths within Oneida and Herkimer Counties. HOCTC began by coordinating with NYSDOT Region 2 staff to identify locations where upgrades to the pedestrian network should be prioritized. Currently, only NYSDOT and a few municipalities between the two counties have any digital record of their sidewalk networks. HOCTC determined the development of a comprehensive sidewalk inventory would facilitate larger scale mapping, analysis, planning and maintenance prioritization.
    - A question was asked about which routes would be inventoried.
      - There will be a GIS inventory using a desktop analysis. There is one community being used as a pilot, but the goal is to inventory all sidewalks.
      - It was noted that the Town of New Hartford has very few sidewalks and they are needed, especially on Higby Road.
    - A question was asked once the inventory is complete, will there be updates?
      - Yes, HOCTC is hoping to create a dashboard to be shared with municipalities and can be updated in real time.
    - A question was asked about the predictive accuracy of a desktop application.
      - Currently, staff is reviewing aerial imagery and there is only line work being done with field verification. ESRI will be used.
  - Slow Moving Vehicles & Agriculture Equipment on Roadways Safety Study Task was added. This task will expand the work started under the Safety Action Plan and establish a data driven process to assist in documenting the safety challenges based in the rural communities.
  - 5311 Mobility Management Activities Task was added. This is more of an active task line because Oneida County has received separate funding sources for this work. This is where the HSTP implementation work will happen as well as the development of the mobility manager.
- Tasks were also updated in the UPWP:
  - Bicycle, Pedestrian, and Non-motorized Transportation System task was updated to include Active Transportation.
  - Complete Streets/Americans with Disabilities Act (ADA) Planning has a separate set aside and it is the last year of IJA and last year to utilize the: Increasing Safety &

- Accessible Transportation Options Metropolitan Planning Set-Aside funding. So, HOCTC will utilize that within this task.
- Consolidation of GIS Task lines to be more inclusive and allow flexibility to adapt to changing technology. For example, Road Scoring/ Pavement Management, traffic counting is something that will continue to happen, but it falls under a more general category of Transportation Data Collection and Analysis.
  - The UPWP aligns with the federal planning factors that were talked about, and it ensures that all modes of travel are included. It engages the community, the decision-making process, aligns the goals and investments, and utilizes data analysis.
  - Programming funding is a balancing act that is all interrelated and coordinated with short- and long-range planning, as well as required administrative and coordinated planning and management of the TIP Program.
  - A quick look at the HOCTC Budget 2026-2027:
    - The pie chart is an illustration of how staff time is allocated to carry-out each of the supporting planning tasks, which includes the maintenance and implementation of the MPO required core documents: Long Range Transportation Plan, Human Services Transportation Plan, Transportation Improvement Plan, Public Participation Plan and Non-Discrimination Demographic Analysis/Title VI Policy. Categories will shrink or expand depending on whether it is an update year for one of those core documents – (for example, even though TIP maintenance is an ongoing core function of the policy committee, staff will not be undertaking the update process this UPWP program year, so it’s showing 2%.)
    - Of the \$1,201,922 budget the allocation received by HOCTC’s is roughly \$500,000 for FHWA PL Funds and an additional \$83,000 in MPP (Transit Planning funds). The balance of the budget incorporates carry-over funds that HOCTC has in reserve for consultant supported studies (during the update years).
    - The “Other Activities” category includes administrative support services to the MPO (printing, travel, equipment, supplies, reproduction, etc.) and just under 20% of that is for consultant supported services. This is why there is not always enough room to undertake studies that fall out of the required activities under the current legislation.
    - We worked cooperatively with NYSDOT Region 2 on the Exit 31 PEL Study to get additional Statewide Planning funds to be able to undertake that study- and we are very fortunate we have that working relationship – and that’s really what the “cooperative” piece of the three C’s planning process is about.
  - When preparing the UPWP, HOCTC circulated a call for projects. Some of the issues heard were:
    - It was identified that there were needs for Freight Planning:
      - Pedestrian, vehicle, and freight access optimization to areas near the Griffiss Chobani site, Turning Stone Resort Casino, and the Nexus Neighborhood.
      - Freight access at Chaminade Road in the Town of Marcy.
      - Traffic safety and connectivity improvements for roadways between NY 840 and Westmoreland I-90 Exit 32.
      - Freight traffic coming into and out of distribution facilities in the Town of Schuyler in Herkimer County.
      - **How addressed in UPWP** This analysis was incorporated into recommendations in the Freight Analysis Technical Memorandum.

- Enhance first and last mile connections focusing on public transit nodes, major employment centers, and areas of high housing density.
    - **How addressed in UPWP:** Planning can be incorporated into new TASKS: Housing and Community Planning, Active Transportation, Complete Streets and Mobility Management.
  - Need to provide pathways to accessible, affordable, and available transportation options that assist in keeping non-institutionalized disabled population active and less isolated.
    - **How addressed in UPWP:** TASKS 5310 & 5311 Transit Service Planning: HSTP Implementation, Mobility Management Activities, formation of Regional Mobility Coordination Council (RMCC), inclusion of consumers in ongoing public engagement activities.
  - Assess the intersection of NYS Route 5 and Dyke Road/Newport Road, including NYS bike parking.
    - **How addressed in UPWP:** TASKS: Roadway Safety Planning, Active Transportation.
5. **NYSDOT Region 2 Report** – *Deborah Windecker, NYDOT gave a synopsis of Region 2 activities this past quarter.*
- NYSDOT hopes that sidewalk inventory will help municipalities with the biannual grants like the Transportation Alternative Program.
    - A pattern that the DOT is seeing is that program delivery is difficult for municipalities.
      - It was asked if there is a better way of achieving maximum reward?
        - NYSDOT Region 2 responded that capacity is always a challenge, so the best method would be for counties to partner with towns (cities, villages) due to additional capacity.
      - A committee member asked NYSDOT if they met with the entire town board or town Supervisor?
        - NYSDOT Region 2 met with Town Supervisor Messa, Rick Sherman the Highway Supervisor and the planning board.
      - A committee member heard that NYSDOT is having difficulty with DEC with permitting, especially getting permitting for some bridge projects.
        - NYSDOT Region 2 explained that the culvert projects are their biggest challenge with DEC. They know that the DEC is looking at streamlining the process and maybe changing some things. However, DEC is making it difficult for NYSDOT to just do a culvert rehab, where DEC would prefer them to replace it. They don't have as many challenges with the bridge projects as with the culverts.
  - Sidewalks come up in every two-year grant cycle in the Town of New Hartford. The Transportation Alternative Program (TAP) final application is due March 12, 2026. It was announced on November 12, 2025, the pre-review was due January 15, 2026. Region 2 has been pleased with the amount of interest in the 6-county area. The award is 80% Federal Funding with a 20% match – if a project is on a state highway, then NYSDOT will cover 15% of the match, leaving only 5% to be covered locally. Awards range from \$0.500M to

\$7.0M, an increase from the last funding round. TAP provides an opportunity for pedestrian enhancements to roll into DOT paving projects.

- Upcoming Projects:
  - Route 46/Wright Settlement Road Intersection Improvement: It is a \$1.9M project and was awarded to Central Paving. It will be completed by the end of 2026. The intersection is going to be replaced with a new signal. The project is going to address geometric deficiencies to improve traffic operations at Wright Settlement and North James Steet (left turn lane North Madison) and improve pedestrian accommodations to Ridge Mills School.
  - Bridge NY 2021- South James Street over Erie Barge Canal in the City of Rome in Oneida County was awarded to Vector at \$1.9M. This is bridge rehabilitation, element specific work, bridge painting, repairs, steel boats, and nuts and joints repairs.
  - Bridge NY 2022- Oswego Road over Fish Creek in the Town of Vienna in Oneida County. This is a \$3.2M bridge rehabilitation project. The funding will cover bridge painting, repairing steel bolts and nuts and joint repairs.
  - Bridge BY 2022- Railroad St. over CSX/Mohawk River & Barge Canal in the Towns of Frankfort/Schuyler in Herkimer County. This project is scheduled to be let in March 2026. It is a \$2.3M bridge rehabilitation project which will repair joints, replace bearings & pedestals, new concrete deck and replace approach slabs. There will be an off-site detour and will be completed at the end of the 2026 season.
- At the last meeting it was noted that the Paving Improvement Program was announced by Governor Kathy Hochul. This program is an investment to renew dozens of vital state roadways across New York State during the 2026 construction season. Oneida and Herkimer Counties were awarded \$15.1M to improve 89 lane miles. Herkimer County was awarded \$4.3 M for 12 lane miles from Route 5 to Route 167 at the village line in Dolgeville. These projects were let in Q4 2025 and are scheduled to be under construction this season.
- Discussion:
  - NYSDOT Region 2 added that with the PEL study wrapping up, they need money to move the project into the next design phases. NYSDOT Region 2 has sought some additional money with federal grants but has not heard about an award yet.
  - Assemblyman Miller is very interested and is pushing for a budget line for design. Region 2 asked if the County Executive could provide any assistance in getting this funding request to state officials.
    - The County Executive said that he would be glad to do what he can to help. He can start with a letter and then he can reach out to Senators. He asked if there was a specific amount NYSDOT Region 2 had in mind?
    - NYSDOT Region 2 responded \$2 million is needed to get started on the design phases and that they want to keep the project progressing.
    - NYSTA would also like to be copied on the letter to get through the planning process since they will be involved in the entire process.

6. **NYS Thruway Report** –*Sara Sherlock, NYSTA gave a synopsis of the activities undertaken by NYSTA this past quarter.*

#### Ongoing Projects:

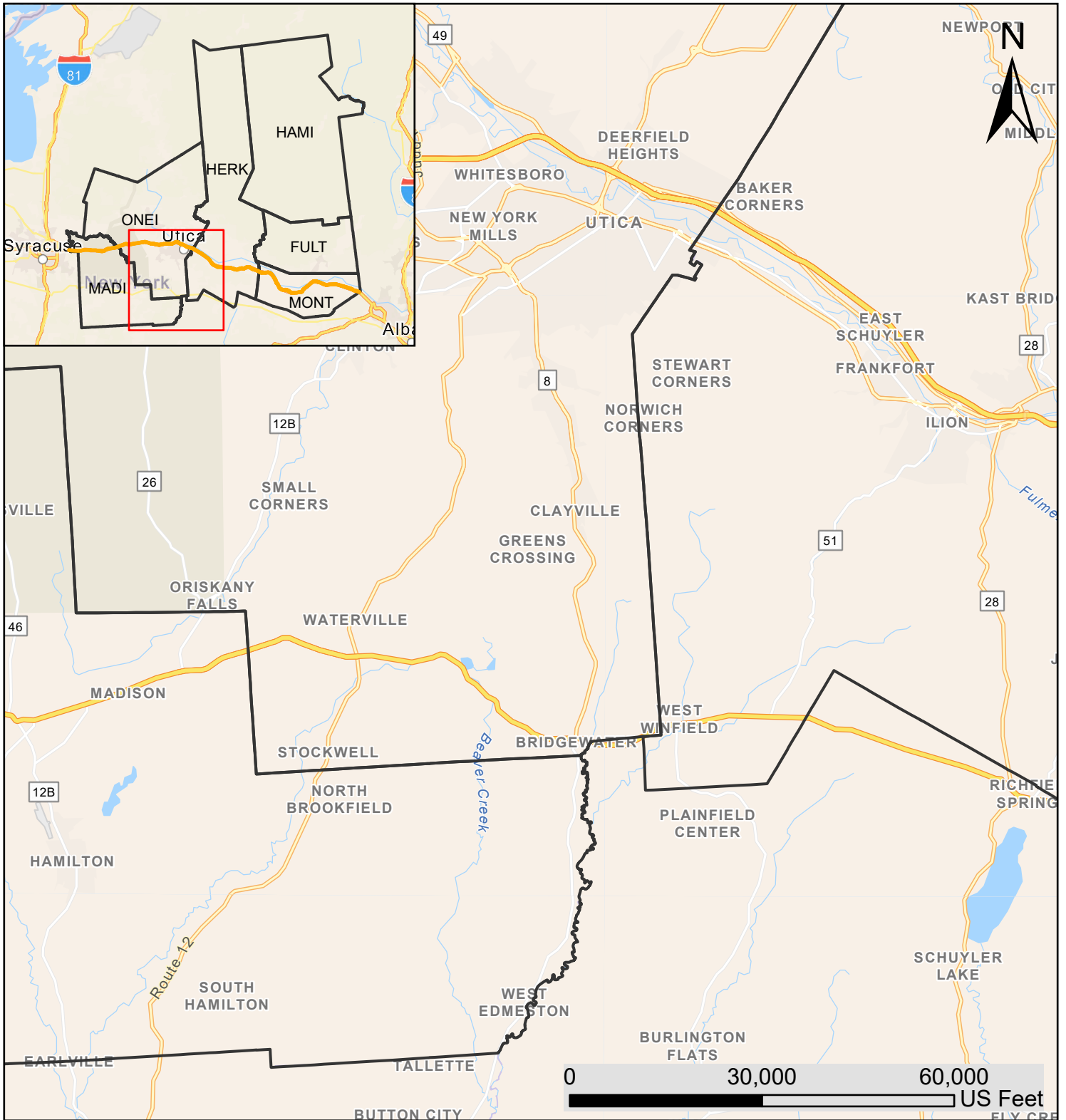

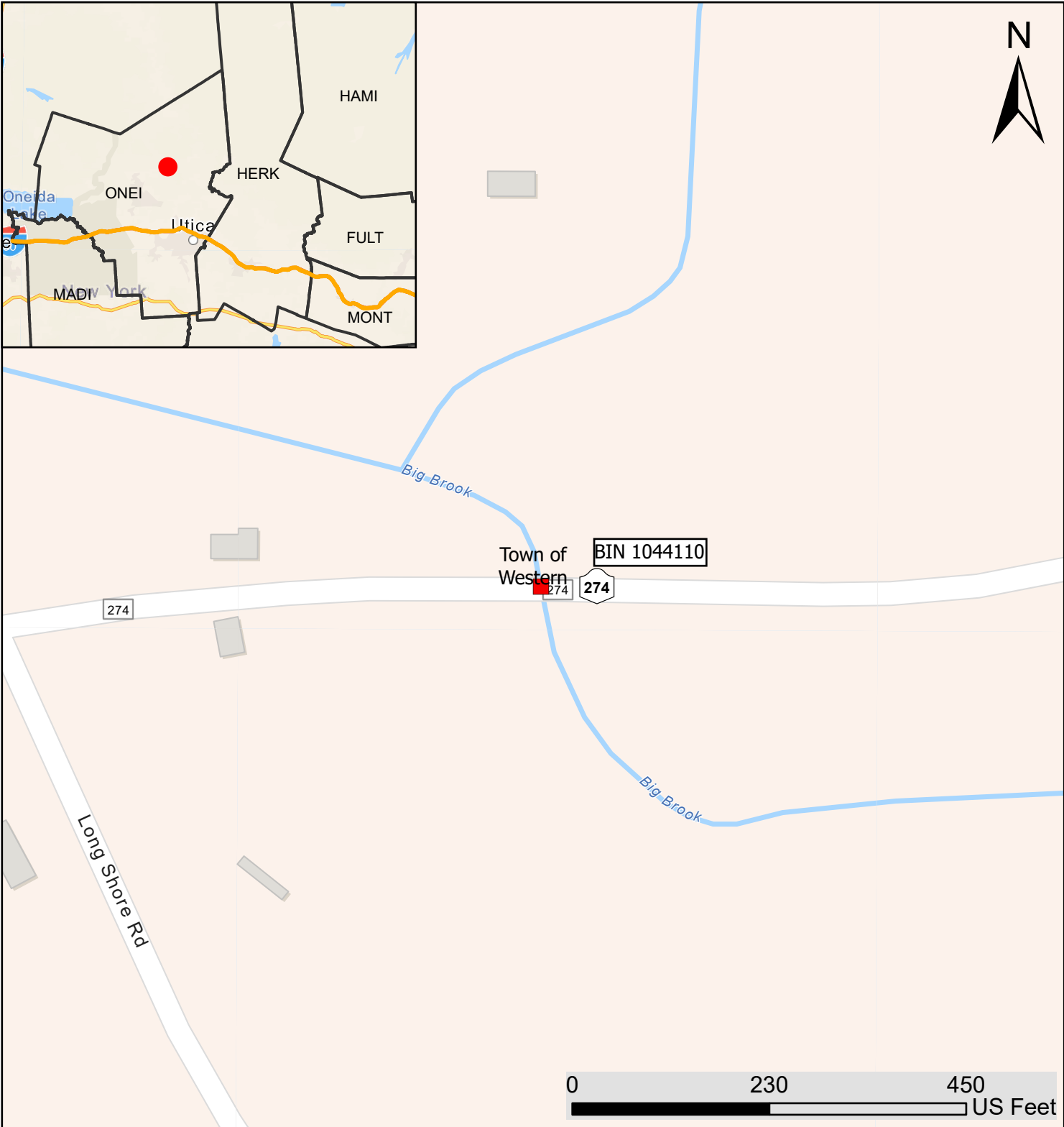

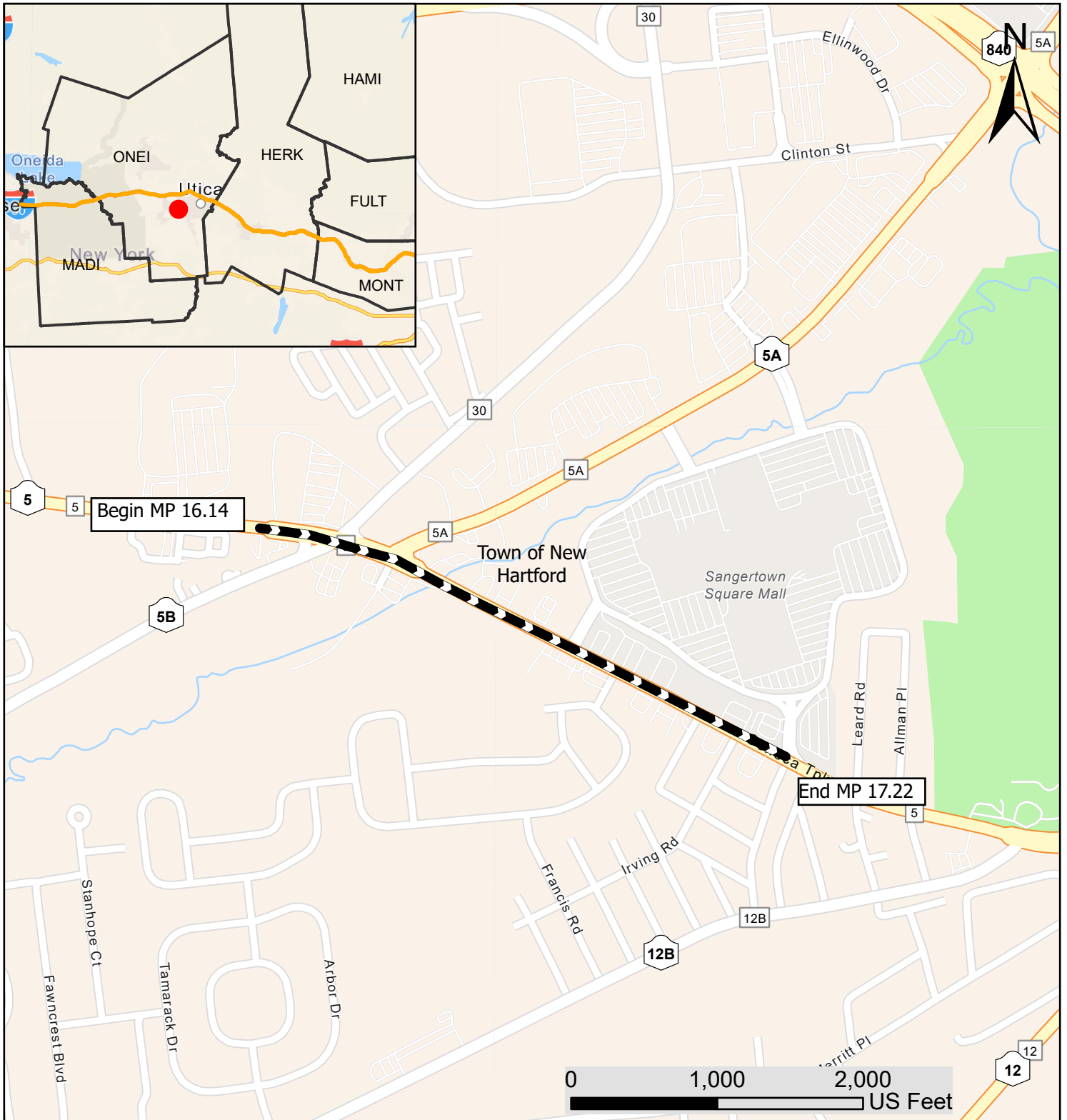

**Agency: Charles T. Sitrin Health Care Center, Inc.**

**Project Request:** Charles T. Sitrin Health Care Center, Inc. is seeking a Section 5310 Program request to replace one Lot G bus that is beyond its useful life and two (2) new Lot E passenger buses for expansion. Based on the community need and interest, Sitrin will be expanding the Adult Day Health Care Program in 2026 to service from 40 registrants per day to 60.

**Project description:** Established in 1974, Sitrin's Adult Day Health Care Program is an area leader in meeting the social and medical needs of adults who wish to engage in daily activities while still enjoying the comfort and independence of living at home. Located at the Sitrin Health Care Center, the program consistently serves 40 registrants each day by providing transportation for community members residing within Oneida and Herkimer Counties. Registrants are comprised exclusively of seniors and individuals with disabilities and approximately 95% are Medicaid recipients.

Based on the community need and interest, Sitrin will be expanding the Adult Day Health Care Program in 2026 to service 60 registrants per day. The use of numerous vehicles is critically vital to ensure registrants can access this essential program and its many services including breakfast, lunch and snacks, cooking workshops, swimming, creative activities, community outings, and themed celebrations as well as personal care assistance, medication administration, physician prescribed treatments, and therapy services.

**Coordination Efforts:** Sitrin receives program referrals from the Rescue Mission, Resource Center for Independent Living, and the Office for Aging and Continuing Care. Due to a consistently full census status, Sitrin routinely refers interested adult day health care registrants to other programs in Oneida and Herkimer Counties for access of services. Unfortunately, other adult day care programs are typically at a full census as well.

**Funding Comments:** Granted funds will be used specifically for the purchase of three vehicles to transport registrants of Sitrin's Adult Day Health Care Program. Support from the New York State Department of Transportation Enhanced Mobility of Seniors and Individuals with Disabilities Program will enable the program to remain financially stable while continuing to provide crucial community-based services.

**Project funding request:** The Visiting Nurse Association is seeking a Section 5310 Program request to fund a new ADA-compliant electric van (Lot B-EV) to transport residents of Nascentia Neighborhood, a thoughtfully planned 72-acre residential community in Rome, NY for adults 55+. Funding from this grant will be used for capital vehicle assistance to acquire the electric van and other capital funding to secure an electric vehicle charger, supporting both the operation and sustainable use of the vehicle.

**Project description:** The van will provide safe and reliable access to medical appointments, social services, community activities, grocery stores, and other essential destinations, reducing isolation and improving quality of life. By creating a dedicated transportation option with electric charging infrastructure, the project addresses the mobility needs of seniors who may face challenges due to physical limitations, rural residence locations, or gaps in existing public transit coverage. This investment ensures continuity of care, expands mobility choices, and enhances residents' independence, connection, and overall well-being while supporting environmentally sustainable operations.

The project aligns with Section 5310 goals by providing a reliable alternative to public transportation for seniors who live in areas under-served by transit or have limited mobility by access to medical care and social programs while reducing reliance on fragmented or costly alternatives. The van complements existing public transit and responds to local needs identified in the coordinated Herkimer-Oneida Counties Human Services Transportation Plan, including gaps in service coverage and the need for flexible and coordinated transportation solutions.

**Coordination Efforts:** Nascentia Health will coordinate with the Herkimer-Oneida Counties Transportation Council, local human service agencies, and community providers to ensure the van integrates with existing resources and reduces service duplication. By scheduling trips around medical appointments, social services, and community programs, the project maximizes efficiency while minimizing additional operational costs. Coordination with agencies also allows for the potential integration of technology-driven scheduling systems and on-demand options to improve flexibility and coverage. This collaborative approach enhances service reliability, expands mobility for residents, and supports innovative, cost-effective transportation solutions tailored to seniors' needs in both urban and rural areas.

**Funding comments:** There is a need for sustainable and flexible transportation infrastructure to support electric vehicles in rural and suburban areas. Without an on-site charging solution, operation of the ADA-compliant electric van would be limited, inefficient, or dependent on off-site charging, reducing service reliability and frequency. Seniors in Nascentia Neighborhood require reliable, consistent access to transportation for medical, social, and community activities.

An Amendment, in the form of an Administrative Modification is made to the Transportation Improvement Program (TIP) when there are revisions of cost changes of \$549,999 or less, an increase in the total cost of the project is less than 10%, when there is a change in funding year for any phase of an existing PIN project, there is an addition of non-federal funds regardless of amount or change in total project cost, or description changes that are not considered to be a change in Project Scope. An Administrative Modification, as per HOCTC TIP procedures, requires approval from the NYSDOT Region 2 RPPM and the HOCTC Director/Program Manager. Joint approval is issued in the form of a jointly signed letter, which is addressed to the NYSDOT Region 2 Director, notifying them of the Administrative Modifications and agreement of the two agencies regarding the action to be taken on the TIP.
